



# **Derbyshire Pension Board meeting notes**

The Derbyshire Pension Board met virtually on 9 November 2020. The Chair, all Board members and officers from the Fund were present.

The following topics were covered and discussed:

# New committee adjudicator

A new adjudicator has been appointed for the determination of appeals against decisions by the Fund at Stage 1 of the adjudication of disagreements procedure.

# **Employer underperformance**

The Fund's officers made the Board aware that a revised charging structure was introduced for employer underperformance on 1 April 2020. It allows for more flexibility and focuses on the recovery of costs instead of fixed level penalties.

# Fund staffing and recruitment

A discussion around the Fund's future staffing levels and recruitment exercises.

# The Pension Board's Terms of Reference

A revised draft version of the Pension Board's Terms of Reference was shared and considered.

The Board agreed to review this document which would be presented to Full Council in due course.

# **Pension Board Annual report 2020**

### **Breaches logs**

An in-depth review of the Fund's Risk Register has been added to the Pension Board's workplan.
