## 2022/2023 Year-end return deadline

For those employers not yet submitting their member data by i-Connect, the deadline for year-end returns was 21 April 2023. All employers that are required to submit year-end will have been contacted by our Technical Team.

## 2023/2024 Contribution returns

All employers should have received their contribution return templates (CR1 Form) for 2023/2024. Please ensure that these are used going forward for the current scheme year.

The deadline for your April 2023 CR1 Form is 19 May 2023.

## Changes for the 2023/2024 year

The Local Government Association has published its [Annual Update](#). It includes important information, such as:

- auto-enrolment earnings bands
- National Insurance thresholds
- LGPS employee contribution bands
- additional pension limit
- annual pensions increase

### Annual allowance limit

The annual allowance is a limit on the value that an individual's pension benefits can grow by in a tax year. A tax charge may be payable if the limit is exceeded.

From 6 April 2023, the standard annual allowance is £60,000 (it had remained at £40,000 for a number of years up to and including the 2022/2023 tax year). Employees are more likely to breach the limit if they're a high earner or have received a promotion.

### Lifetime allowance limit

The lifetime allowance (LTA) is the total amount of pension an individual can build up from all their pension savings over their lifetime, before they pay a tax charge.

The current limit of £1,073,100 will remain until the tax year beginning 6 April 2024, at which point the LTA will be abolished. However, there will be no LTA charges for the period 6 April 2023 to 5 April 2024.
