### MHCLG consultations

This year the Ministry of Housing, Communities and Local Government (MHCLG) launched a number of consultations that are likely to impact the LGPS regulations in the years to come, including:

We're expecting to receive an update from MHCLG on each consultation, and how they are progressed, during 2026.

We would like to thank all employers that took the time to review the prospective changes and respond. Your input helps to shape the future of the LGPS.

### Member events

We hosted our latest member engagement forum in July 2025. Members in attendance provided helpful and insightful feedback on a range of topics. This included the Fund's main communications through Annual Benefit Statements for [Active](#) and [Deferred](#) members and the development of the [My Pension Online](#) platform.

The feedback provided will be taken into consideration by the Fund when preparing next year's Annual Benefit Statements.

In September 2025, we also hosted two online events during Pensions Awareness Week. Over 400 people attended the events, and the recordings are available on [our website](#) along with copies of the questions and answers from each session. The events covered a general overview of the LGPS, and retirement planning.

Thank you for sharing this, and our other messages with your LGPS members. This promotes a higher turnout at these events which is valuable in providing members with information about the scheme in a format that suits them. We appreciate your continued assistance in sharing future communications from the Fund.

## My Pension Online is getting an upgrade



In mid-January 2026 we are expecting an upgrade to our member self-service platform, [My Pension Online](#).

The upgrade will boast a fresh look for the site, whilst introducing new security features:

- **SMS Multi-Factor Authentication** – Users will be prompted to enter their mobile number to receive one-time passcodes to use the site.
- **Electronic ID verification (EIDV)** – For new registrations, members can use EIDV to verify their identity to register for the service.

After the upgrade has gone live, we'll share some more promotional materials for you to use on notice boards and employee intranet sites. My Pension Online will continue to be developed with new functionality which we're excited to share with you in due course.
